FINANCIAL REPORT

Discuss Fund Drive for the Peanut Genome Initiative

George Birdsong, Chairman of the Genomics Fund Raising Committee, gave the following update to the Board;

Pledges and Funds Received:

NPB \$400,000/year for 5 years 3 Sheller Associations \$400,000/year for 5 years

Next Steps:

Solicit commitments from the Manufactuer/Allied segments. Victor Nwosu, Hugh Nall, and Tyron Spearman will assist with the solicitations in their segments along with Birdsong and Howard Valentine. The goal for these segments is a total of \$400,000.

Howard Valentine then explained to the Board that our budget for 2013 is \$1,460,000 of which we will owe BGI \$1,120,000 mid-year. Therefore he encouraged those who have committed to move pledges forward if possible so we could stay on line with the research plan. Particularly the phenotyping and gene function areas need to be fully funded to match with the sequence data.

Peanut Genomic Initiative Update

Howard Valentine gave the Board an update on the progress to date on the new five year Strategic Plan:

- All materials required by BGI except the two diploid have been received by them for the sequencing work. Sequencing on the tetraploid has already begun.
- Key US and international genetic researchers attended the Legume Crop Genomics meeting in Hyderabad, India in October. They also attended a Peanut Genomic Initiative Workshop during this meeting as well. Over 50 peanut researchers attended this workshop. Plans were made during this meeting on setting up the system for phenotyping the various RIL populations. ICRISAT in India agreed to conduct a WebEx session during November to demonstrate their software and nomenclature for the phenotyping work. Corley Holbrook, USDA Tifton, will organize this effort

• Valentine also announced that plans have been finalized for the next International Peanut Genomics Meeting. It will take place in June 17-19, 2013 in Zhengzhou, China. Sponsors for the meeting are being arranged by the Chinese members of the PGC and will put together the various speakers and general program for the meeting. Rich Wilson and Tom Stalker, NCSU, will assist in this effort. It is anticipated that as many as 25 US peanut researchers will attend.

New Business

- Valentine updated the Board on the plans to review the 2013 genomic proposals on December 19 in Atlanta. Several review panel members from other legume crops will lead the review with a representative from each segment of the industry. The Board will be asked to approve the projects for funding in a December 20 conference call.
- The proposal request letter for general projects was also approved. Valentine also stated that work has begun on a new website for submission of the general projects in March. Review of these proposals would occur on March 14 at the spring meeting in Atlanta. The Board is also requested to attend oral presentations from the researchers funded in 2012 on the same day.
- Valentine also reviewed a recent press release from the University of Florida about a new peanut treatment developed there called Pulsed Ultraviolet Light (PUV). This process is reported to change the proteins so that they cannot attach to peanut antigens.

There being no further business the meeting was adjourned.
