#### CALL TO ORDER/APPROVAL OF AGENDA

## **FINANCIAL REPORT**

Alan Ayers and Renee Rye, gave the Board an overview of the Foundation's Financial Report through April 30, 2014. All the reserve funds are at levels set by the Board. Total Assets are at \$2,426,122 with Total Liabilities at \$1,771,193. This leaves us with Total Net Assets of \$654,929. It was moved, seconded and carried to:

Approve the April 30, 2014 financial report as presented.

#### Replacing Texas Peanut Producers Board member

Valentine presented the suggestion of the Texas Peanut Producers Board that their representative, Haldon Messermore, be replaced by Grayson Wilmoth. It was moved and seconded to:

To approve Grayson Wilmoth as the Texas Peanut Producers Board representative.

#### List of Projects Funded for 2014 & Status of Memorandum of Agreements

Valentine reviewed the projects funded so far for 2014 totaling \$835,000. More proposals will be funded as donations are received.

The Foundation has made some changes in their standard Memorandum of Agreements to more clearly define that any data produced on a genomics funded project will be made publically available. Several universities have asked for modification to ensure that new varieties produced with these funds and additionally university funds could be protected

under the Plant Variety Protection system. The Board agreed to these modification to accommodate these request.

## **Peanut Genomic Initiative Update**

Howard Valentine gave the Board an update on the progress to date on the new five years Strategic Plan:

- BGI has completed the sequencing of both the tetraploid (commercial peanut) and the two diploids (wild parents). The diploids have been assembled and work is progressing on the tetraploid assembly.
- Work is still progressing on the publication of the successful sequencing and assembly of the two diploid species. Outline for the paper is completed and various researchers have been assigned to write each section. Lutz Froeneke, UC Davis, is coordinating this report.
- Several teams are working on phenotyping the RIL populations to find varieties that have resistance to diseases or quality traits we are looking for. Teams in the U.S., China, India and Brazil are all working together on this effort.
- Final planning for the International Peanut Genomics meeting (AAGB-14) in Savannah is underway. It will be held at the Marriot Hotel from November 11-14, 2014. It is expected that over 120 delegates will attend. Many will present papers on their progress.

#### **New Business**

#### 2015 BUDGET & STAFF DISCUSSION (Closed Session)

• The Board met in closed session to discuss the hiring of Steve Brown to replace Howard Valentine on January 1, 2015. A motion was made and seconded to:

Hire Steve Brown as the new Executive Director effective January 1, 2014

It was also moved and seconded to:

Retain Howard Valentine at his present salary through September 30, 2014 to assist in the transition

• The draft budget for fiscal year 2014-2015 was also presented to the Board. Income is expected to be similar to 2013-2014 with most of the funds directed for genomics research. Expenditures are similar to 2014 with the exception of additions funds set aside for the International Peanut Genomics Initiative (AAGB-14) in Savannah, GA in November of 2014.
